# **Prop 204 Grant Successfully Concluded**

A three-year program of watershed education, monitoring, and watershed restoration funded by California Proposition 204 concluded last November. The final report for this effort is complete and available for review by anyone who is interested. The report is available at the CMRCD office, at the River Center, and at the County Library.

This \$500,000 grant contributed to:

- Two large restoration projects and several smaller efforts.
- Over two dozen monitoring sites to document watershed trend on private land.
- The work of our education program, leading to the new River Center.

We are proud of how much was done with this funding, and we think the taxpayers got good value for their money. Especially when you consider that over \$100,000 of local cash and in-kind contributions were added to the grant to stretch the dollars further.

### **Current Projects**

We have a number of new projects starting real soon. A formal comment period will be announced to comply with environmental regulations. For a full list of active and proposed projects, visit the CMRCD website or give us a call.

### **How We Can Fund Your Project**

New funding opportunities come up regularly, but it can take up to two years to obtain funds for your project. So start now! Our next big proposal for state funds will be coming up soon, and we would like to hear your ideas for projects to include in our next proposal.

Projects that are good candidates for funding include:


- Fencing to establish riparian meadows and corridors or to protect wetlands.
- Off-site water sources in conjunction with riparian/ wetland protection.
- Stabilization of streambank erosion.
- Treatment of gullies, especially in meadows.

# Witcher Creek Project



Before Photo: The channel of Witcher Creek was suffering from too much livestock pressure. The roots of the meadow grasses were too weak to bind the soil. The channel was getting wider as valuable topsoil washed away.



After Photo: After a season of rest, the vegetation is recovering. A series of grade control structures is set to be installed later this year. These structures will stop the erosion, and capture sediment to build the channel back up. The meadow will hold more water for better sub-irrigation in the future. This riparian pasture can be returned to the grazing rotation after a few years of rest.

Cleaner water, less erosion, better habitat for fish and wildlife, and better productivity.

# **Watershed Assessment Update**

VESTRA Resources, Inc., from Redding anticipates the Pit River Watershed Assessment to be completed by fall, 2003.

The contract funded by CALFED was awarded to VESTRA Resources of Redding in the fall of 2001. The goal for the watershed assessment is to prepare a balanced document that will serve as an educational tool to provide available information to stakeholders, build consensus within the watershed, and provide a baseline for future action. The assessment will contain physical watershed characteristics, general watershed history, land use, demographics, geomorphology, hydrology, water quality, vegetation resources, wildlife resources, cultural resources, fire and fuel management, and fisheries and aquatic resources.

- Removal of levees left over from stream channelization.
- Development of nutrient uptake lagoons to treat feedlot runoff.
- Wetland restoration or enhancement.
- Habitat enhancement (when associated with streams and wetlands.)
- Or your new idea!

Any project proposals that contribute to cleaner water will be considered. We can't promise that every project will be funded, but we can promise that all proposals will be considered.

In order to qualify for funding, landowners must agree to:

 Participate in the project planning and long term monitoring.

- Participate in getting the on-the-ground work done.
- Maintain improvements for a specified time.
- Abide by agreed Best Management Practices to ensure project goals are met.

If you are used to working with NRCS programs, this will not be all that different. In fact, many of the state grant funds administered by CMRCD can make up part of the required match for NRCS programs such as EQIP. If you are cooking up an EQIP proposal, chances are it would qualify for additional state funding.

If the new EQIP match requirements are going to be difficult for you to reach, let us help bridge the gap!
